## POST-TRANSITION PERIOD BUSINESS AND TRADE SUPPORT

We are now three months into our new trading relationship with the EU. As a Government we are doing our utmost to help businesses understand the implications of, and capitalise on the opportunities that come from, the excellent deal we reached in December. This is how we will boost productivity, unlock investment and safeguard high value jobs in the UK.

Many businesses have prepared well, and are adapting to the new trading environment. Nonetheless, we appreciate this is a period of change for businesses, made all the more extraordinary by responding to a global pandemic. We also appreciate there have been particular issues relating to trade in goods with Northern Ireland.

Government departments have been engaging extensively with businesses across all sectors of the UK economy to support businesses adapt to our new trading relationship with the EU and compete on a global stage. Ministers talk regularly to businesses including through the weekly Brexit Business Taskforce.

We recognise however that some issues remain and that you will be getting messages highlighting them from constituency businesses. We are of course always ready to have such problems drawn to our attention directly. There are also teams across Government whose job it is to support businesses and we wanted to make sure you were aware of how to contact them. Please do draw the following details to businesses as necessary - they will then be able to access help directly.

### GOV.UK

The best place to go for guidance about changes and new rules for doing business with the EU and for moving goods from Great Britain to Northern Ireland is the Transition Page on GOV.UK.

#### Northern Ireland

- The free-to-use <u>Trader Support Service</u> provides end-to-end support for businesses engaged in new processes under the Northern Ireland Protocol.
- The Movement Assistance Scheme means traders do not need to pay certification costs
  for moving agri-food goods from GB-NI, with the costs incurred by those certifying the
  products reimbursed by the government up to a set amount. The scheme also includes a
  dedicated helpline for general enquiries and together these measures are making it
  easier to move agri-food goods from Great Britain to Northern Ireland.
- Comprehensive business guidance on moving all different kinds of goods into, out of, or through Northern Ireland is set out on gov.uk on this <u>collections page</u>.

We also attach fuller information on the support and guidance available to businesses in your constituency. In addition to this information, your local business and other communities may also be interested in the Transition campaign's <u>partner resource collection</u> for products and assets to help raise awareness of the required changes. Additionally, we have also attached a breakdown of responsibilities by department for correspondence relating to UK-EU customs and trade post-transition.

Finally, we wanted to highlight the fact that the Government has provided a range of financial support to businesses during this period including more than £200bn of economic support since March as part of our response to Covid-19 and a new £20m SME Brexit Support fund to help SMEs adjust to new customs, rules of origin, and VAT rules when trading with the EU. Further guidance on this new fund can be found here.

We have also provided dedicated support packages to traders moving goods from Great Britain to Northern Ireland, including a new and unprecedented Trader Support Service, backed by funding of more than £200m, providing end-to-end support for businesses engaged in new processes under the Protocol, and the agri-food Movement Assistance Scheme, which supports traders by covering the costs of certification for agri-food products.

We hope this information proves useful to you and businesses in your constituency.
